Sec. 2-13. Salary of the mayor.

The salary of the mayor shall be \$105,000.00 per annum, and such salary shall also include all other benefits afforded to full time continuous service employees of the city, and the use of an automobile.

The members of the city council shall receive on a bi-annual basis a salary equal to nine percent of the annual compensation of the mayor effective the first Monday in January, 2014.
