AD HOC COMMITTEE ON AGGREGATE INDUSTRIES **JUNE 25, 2015**

P486-15 COUNCILLOR OSBORNE – Reporting for the Ad Hoc Committee on Aggregate Industries – The Ad Hoc Committee on Aggregate Industries met tonight to discuss violations to their Special Permit that occurred on Wednesday, March 25; Saturday, March 28; and Friday, April 10 regarding trucks entering and existing the property outside of the business hours of the plant that were stated in their Special Permit and also to address the complaint of trucks backing up on Russell Street and idling before operating hours. There was much discussion between the representatives from Aggregate Industries and also the representatives of the neighborhood group, who were also in attendance. Aggregate did admit that one of the violations that did occur was indeed a violation and they took exception to some of the others as being maintenance, as opposed to picking up products, so they questioned a couple of what the council called violations. Councillor Sinewitz after much discussion made a motion to fine Aggregate Industries \$300 for the one admitted violation. Councillor Garabedian made an amendment to the motion to fine Aggregate Industries \$300 for each violation, thus the fine would be \$900. (Report received)

COMMITTEE OF THE WHOLE
JUNE 23, 2015

P496-15 COUNCILLOR WALSH – Reporting for the Committee of the Whole - The Committee of the Whole met on Tuesday, June 23, 2015, for the purpose of hearing a presentation by Kinder Morgan Energy Partners with regards to the proposed installation of a high-pressure gas pipeline in the City of

Peabody, proposed to be located along the bike path to the rear of Glen Drive, Gates Road, the Aggregate Quarry, and Emily Lane. Present were Councillors: Moutsoulas, Gould, Saslaw, McGinn, Manning-Martin, Sinewitz, and Walsh. The meeting was well attended by Peabody residents most, if not all, of whom were in opposition. Appearing on behalf of Kinder Morgan were Steven Keady and Mike Lennon. Kinder Morgan conducted a 20-minute power point presentation outlining the proposed route of the new pipeline, and the needs and benefits for a new pipeline.

Mayor Bettencourt addressed the committee and stated the City's opposition to the proposal. Several City Department Heads and Board Members were in attendance, including Sharon Cameron from the Board of Health, Lucia DeNegro, and Michael Rizzo from the Conservation Commission, Inspector Chris Dowling from the Fire Department, and Robert Langley, Director and Will Paulitz, City Engineer from Public Services Department. State Representative Theodore Speliotis spoke on the matter; also in attendance was State Representative Leah Cole and a representative from Senator Joan Lovely's Office, and a representative from Senator Elizabeth Warren's Office.

Residents appearing to speak in opposition were Gregory Bunn, 44 Trask Road, Kurt Anderson, 7 Belfast Road, Harvey and Diane Elfson, 19 Glen Drive, Thomas Lyons, 35 Glen Drive, Robert Croce, 128 Goodale Street, and Mitchell Cole, 39 Glen Drive. Those opposed generally stated there would be no direct benefit to the City of Peabody, safety concerns taking into account two other existing high-pressure gas pipelines in the area, safety concerns with an active sand and gravel quarry, and the negative effect to the valuation of the homes in the area.

The Committee questioned representatives from Kinder Morgan about what the benefits of a new pipeline would be for the City, the safety concerns as stated by the residents, and the possibility of Kinder Morgan applying for an Article 97 waiver with regards the use of public land designated as open space/recreation. An Article 97 waiver would require a 2/3rd's vote of the House and Senate on Beacon Hill. After a debate that lasted about an hour and a half, the following motions were approved in committee. (Report received)
