SECTION ONE: That the Zoning Ordinance of the City of Peabody entitled, City of Peabody Zoning Ordinance Adopted April 28, 2011, and amended through July 18, 2017, is hereby further amended as follows:

By repealing the following Section 6.14 entitled Temporary Moratorium on the Sale and Distribution of Recreational Marijuana:

There shall be a temporary moratorium through December 31, 2018, on the usage of land or structures for a Recreational Marijuana Establishment and Marijuana Retailer which use shall include, without limitation, the operation of any marijuana establishment, as defined in G.L. c. 94G, Section 1, including, without limitation, a marijuana cultivator, marijuana testing facility, marijuana product manufacturer, marijuana retailer or any other type of licensed marijuana-related business. This prohibition shall not apply to the sale, distribution or cultivation of marijuana for medical purposes licensed under Chapter 369 of the Acts of 2012.

And adding in place thereof the following new Section 6.14 as follows:

6.14 Marijuana Establishments Prohibited

The operation of any marijuana establishment, as defined in G.L. c. 94G, Section 1, including, without limitation, a marijuana cultivator, marijuana testing facility, marijuana product manufacturer, marijuana retailer or any other type of licensed marijuana-related facility, is prohibited in all zoning districts of the City. This prohibition shall not apply to the sale, distribution or cultivation of marijuana for medical purposes licensed under Chapter 369 of the Acts of 2012.

SECTION TWO: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION THREE: This ordinance shall take effect as provided by law. (Carried 10-1; Councillor Saslaw opposed)

- 5. Minimize the total number of poles required;
- 6. Consider any potential noise issues as indicated in the Health Department response;

Regarding petition 5 / sc30 evaluate options to consider criteria 2, 3 & 4 above

Regarding all 14 petitions, utilize poles that look like and function as light poles.
